**Norman and Marion Bright Memorial Award** 

**Terms of Reference** 

The award shall be presented to an individual who has made an outstanding contribution in Canada to the furtherance of

chemical technology. The person so honoured may be either a chemical sciences technologist, or a person from outside

the field who has made a significant and noteworthy contribution to its advancement.

Deadline: December 1 for the following year's award

Sponsor: CIC Chemical Education Fund

Award: A framed certificate, an honorarium of \$500.

Nominations must include:

A detailed outline of the contribution of the nominee to the advancement of chemical technology, and the reasons why the Award is merited. Technical scientific achievement need not be the only consideration in the

assessment of a nominee.

Curriculum Vitae (maximum nine pages).

Supporting Letters (1 or more)

Membership in the Institute is not a prerequisite for this award.

All nominations will remain in force for three years. Nominators are responsible for keeping the record of the nominee up

to date and complete.

**Selection Committee:** 

CSCT President (chair)

Up to three additional members as appointed by the CSCT Board

The award shall be presented annually unless the committee considers that no suitable candidate has been nominated.

This award was established by the Canadian Society for Chemical Technology (CSCT) to commemorate the devotion of

Norman and Marion Bright to the Chemical Institute of Canada, culminating in Norman's service as Treasurer from 1967-

1970, and Marion's as Manager of Membership Services from 1970-1974.

### **Award for Chemistry Teaching At Community and Technical Colleges**

#### (Presently not offered)

The Award shall be offered each year to an outstanding teacher in the area of chemistry, biochemistry, chemical engineering technology or chemical technology.

#### Award: \$1,000 and a framed scroll.

Deadline: December 1 for the following year's award

**Eligibility:** The award shall be presented to an individual who has contributed to teaching and has had a great influence upon students. Meritorious contributions of an administrative or other nature shall received secondary considerations. The staff of any community college, technical institute or Cegep in Canada is eligible.

#### Nominations must include:

- A detailed description of the contribution of the candidate to the teaching of chemistry.
- Supporting Letters (1 or more)

Each nomination shall remain in force for three years, and if necessary, shall be referred annually to the Selection Committee.

#### **Selection Committee:**

- CSCT Vice President (chair)
- A previous winner
- One other person as appointed by the Award Chair

The Selection Committee may, at its discretion, withhold an award if no nominations of sufficient merit are submitted.
