1. Call to Order

The meeting was called to order by the CSC President, Jennifer Love, FCIC, at 12:30 CT. Love completed a land acknowledgment.

CSC President

Love summarized the CSC activities from the report available to the membership online.

CSC Treasurer

Lai discussed key aspects and concerns from his submitted report and the audited financial statement.

CIC Executive Director

Tsang highlighted events, National Team updates, activities, initiatives, and progress that took place since the last report to membership.

CSC Directors

PowerPoint slides containing brief updates for each of the Directors' activities were shown for the membership to read for 15 seconds each in the following order: Vice President, Accreditation, Awards, Conferences, Industry Liaison, Local Sections, Student Affairs, Subject Divisions, EDI, Directors-at-Large, and NSERC Chemistry Liaison.

- Michael Gravel: What is the health of the balance sheet like, for example is the revenue 30%? Is the CSC back on track after the past 4 years that have been difficult financially?
 - Lai answered: Yes, the CSC is back on track financially. The CSC netted \$400,000 which is 50-70% of the CSC's revenue. Conference revenue was \$7,000 above budget, although investment revenue was slightly lower than expected.

The Chair of the Nominating Committee, Prof. Mark Workentin, was approved by the CSC Board in late February. The call for nominations and submissions was reviewed by the committee, the selected individuals were recommended to the CSC Board, and then brought to the membership for a vote due the night before the AGM in June. Zou acknowledged that the process this year was not perfect and Prof. Mark Workentin helped provide feedback on the process to implement next year.
